# RARITA-SCHWINGER TYPE OPERATORS ON SPHERES AND REAL PROJECTIVE SPACE 

Junxia Li, John Ryan, and Carmen J. Vanegas


#### Abstract

In this paper we deal with Rarita-Schwinger type operators on spheres and real projective space. First we define the spherical Rarita-Schwinger type operators and construct their fundamental solutions. Then we establish that the projection operators appearing in the spherical Rarita-Schwinger type operators and the spherical Rarita-Schwinger type equations are conformally invariant under the Cayley transformation. Further, we obtain some basic integral formulas related to the spherical Rarita-Schwinger type operators. Second, we define the Rarita-Schwinger type operators on the real projective space and construct their kernels and Cauchy integral formulas.


## 1. Introduction

Rarita-Schwinger operators are generalizations of the Dirac operator and arise in representation theory for the Spin and Pin groups. See [3, 4, 6, 14, 15]. We denote a Rarita-Schwinger operator by $R_{k}$, where $k=0,1, \ldots, m, \ldots$. When $k=0$ we have the Dirac operator. The Rarita-Schwinger operators $R_{k}$ in Euclidean space have been studied in [3, 4, 6, 14, 15]. Here we construct similar Rarita-Schwinger operators together with their fundamental solutions and study their representation theory on the sphere and real projective space.

First J. Ryan [12, 11] in 1997 and P. Van Lancker [13] in 1998 studied the Dirac operators on the sphere. Later, H. Liu and J. Ryan [8] studied the spherical Dirac type operators on the sphere by using Cayley transformations. See also [1]. Using similar methods to define the Rarita-Schwinger operators in $\mathbb{R}^{n}$, we can define the spherical Rarita-Schwinger type operator on the sphere based on the spherical Dirac operator. We also use similar arguments as in Euclidean space to establish the conformal invariance for the projection operators and the spherical Rarita-Schwinger type equations under the Cayley transformations. See 6]. Further the fundamental solutions to the spherical Rarita-Schwinger type operators are achieved by applying the Cayley transformation. In turn, Stokes' Theorem, Cauchy's Theorem, Borel-Pompeiu Formula, Cauchy Integral Formula and a Cauchy Transform are proved for the sphere. Furthermore, we show that Stokes' theorem is

[^0]conformally invariant under Cayley transformation, and with minor modification, is equivalent to the Rarita-Schwinger version of Stokes' Theorem in Euclidean space appearing in [3) 6] and elsewhere.

By factoring out $\mathbb{S}^{n}$ by the group $\mathbb{Z}_{2}=\{ \pm 1\}$ we obtain real projective space, $\mathbb{R} P^{n}$. On this space, we define the Rarita-Schwinger type operators and construct their kernels over two different bundles over $\mathbb{R} P^{n}$. Further, we obtain some basic integral formulas from Clifford analysis associated with these operators for the two different bundles. This extends results from [7].

## 2. Preliminaries

A Clifford algebra, $\mathrm{Cl}_{n+1}$, can be generated from $\mathbb{R}^{n+1}$ by considering the relationship

\underline{x}^{2}=-\|\underline{x}\|^{2}
$$

for each $\underline{x} \in \mathbb{R}^{n+1}$. We have $\mathbb{R}^{n+1} \subseteq \mathrm{Cl}_{n+1}$. If $e_{1}, \ldots, e_{n+1}$ is an orthonormal basis for $\mathbb{R}^{n+1}$, then $\underline{x}^{2}=-\|\underline{x}\|^{2}$ tells us that $e_{i} e_{j}+e_{j} e_{i}=-2 \delta_{i j}$. Let $A=\left\{j_{1}, \ldots, j_{r}\right\} \subset$ $\{1,2, \ldots, n+1\}$ and $1 \leq j_{1}<j_{2}<\cdots<j_{r} \leq n+1$. An arbitrary element of the basis of the Clifford algebra can be written as $e_{A}=e_{j_{1}} \ldots e_{j_{r}}$. Hence for any element $a \in \mathrm{Cl}_{n+1}$, we have $a=\sum_{A} a_{A} e_{A}$, where $a_{A} \in \mathbb{R}$.

The reversion is given by

$$
\tilde{a}=\sum_{A}(-1)^{|A|(|A|-1) / 2} a_{A} e_{A},
$$

where $|A|$ is the cardinality of $A$. In particular, $\widetilde{e_{j_{1} \ldots e}^{j_{r}}}=e_{j_{r}} \ldots e_{j_{1}}$. Also $\tilde{a b}=\tilde{b} \tilde{a}$ for $a, b \in \mathrm{Cl}_{n+1}$. The Clifford conjugation is defined by

$$
\bar{a}=\sum_{A}(-1)^{|A|(|A|+1) / 2} a_{A} e_{A}
$$

and satisfies $\overline{e_{j_{1}} \ldots e_{j_{r}}}=(-1)^{r} e_{j_{r}} \ldots e_{j_{1}}$ and $\overline{a b}=\bar{b} \bar{a}$ for $a, b \in \mathrm{Cl}_{n+1}$.
For each $a=a_{0}+a_{1} e_{1}+\cdots+a_{1 \ldots n+1} e_{1} \ldots e_{n+1} \in \mathrm{Cl}_{n+1}$ the scalar part of $\bar{a} a$ gives the square of the norm of $a$, namely $a_{0}^{2}+a_{1}^{2}+\cdots+a_{1 \ldots n+1}^{2}$. For more on Clifford algebras and their properties, see [9.

The Pin and Spin groups play an important role in Clifford analysis. The Pin group can be defined as

$$
\operatorname{Pin}(n+1):=\left\{a \in \mathrm{Cl}_{n+1}: a=y_{1} \ldots y_{p}: y_{1}, \ldots, y_{p} \in \mathbb{S}^{n}, p \in \mathbb{N}\right\}
$$

and it is clearly a group under multiplication in $\mathrm{Cl}_{n+1}$.
Now suppose that $y \in \mathbb{S}^{n} \subseteq \mathbb{R}^{n+1}$. Look at $y x y=y x^{\|_{y}} y+y x^{\perp_{y}} y=-x^{\|_{y}}+x^{\perp_{y}}$ where $x^{\|_{y}}$ is the projection of $x$ onto $y$ and $x^{\perp_{y}}$ is perpendicular to $y$. So $y x y$ gives a reflection of $x$ in the $y$ direction. By the Cartan-Dieudonné Theorem each $O \in O(n+1)$ is the composition of a finite number of reflections. If $a=y_{1} \ldots y_{p} \in$ $\operatorname{Pin}(n+1)$, then $\tilde{a}:=y_{p} \ldots y_{1}$ and $a x \tilde{a}=O_{a}(x)$ for some $O_{a} \in O(n+1)$. Choosing $y_{1}, \ldots, y_{p}$ arbitrarily in $\mathbb{S}^{n}$, we see that the group homomorphism

$$
\theta: \operatorname{Pin}(n+1) \longrightarrow O(n+1): a \longmapsto O_{a}
$$

with $a=y_{1} \ldots y_{p}$ and $O_{a}(x)=a x \tilde{a}$, is surjective. Further $-a x(-\tilde{a})=a x \tilde{a}$, so 1 , $-1 \in \operatorname{ker}(\theta)$. In fact $\operatorname{ker}(\theta)=\{ \pm 1\}$. See [9]. The Spin group is defined as

$$
\operatorname{Spin}(n+1):=\left\{a \in \operatorname{Pin}(n+1): a=y_{1} \ldots y_{p} \text { and } p \text { even }\right\}
$$

and it is a subgroup of $\operatorname{Pin}(n+1)$. There is a group homomorphism

$$
\theta: \operatorname{Spin}(n+1) \longrightarrow S O(n+1)
$$

which is surjective with kernel $\{1,-1\}$. See $[9$ for details.
The Dirac Operator in $\mathbb{R}^{n}$ is defined to be

$$
D:=\sum_{j=1}^{n} e_{j} \frac{\partial}{\partial x_{j}}
$$

Note $D^{2}=-\Delta_{n}$, where $\Delta_{n}$ is the Laplacian in $\mathbb{R}^{n}$.
If $p_{k}$ is a homogeneous polynomial with degree $k$ such that $D p_{k}=0$, we call such a polynomial a left monogenic polynomial homogeneous of degree $k$.

Let $\mathcal{H}_{k}$ be the space of $\mathrm{Cl}_{n+1}$-valued harmonic polynomials homogeneous of degree $k$ and $\mathcal{M}_{k}$ the space of $\mathrm{Cl}_{n+1}$-valued monogenic polynomials homogeneous of degree $k$. Note if $h_{k} \in \mathcal{H}_{k}$, then $D h_{k} \in \mathcal{M}_{k-1}$. But $\operatorname{Dup}_{k-1}(u)=(-n-2 k+$ 2) $p_{k-1}(u)$, so

$$
\mathcal{H}_{k}=\mathcal{M}_{k} \bigoplus u \mathcal{M}_{k-1}, \quad h_{k}=p_{k}+u p_{k-1}
$$

This is the so-called Almansi-Fischer decomposition of $\mathcal{H}_{k}$. See [2, 10].
Note that if $p(u) \in \mathcal{M}_{k}$ then it trivially extends to $P(v)=p\left(u+u_{n+1} e_{n+1}\right)$ with $u_{n+1} \in \mathbb{R}$ and $P(v)=p(u)$ for all $u_{n+1} \in \mathbb{R}$. Consequently $D_{n+1} P(v)=0$ where $D_{n+1}=\sum_{j=1}^{n+1} e_{j} \frac{\partial}{\partial u_{j}}$.

If $p(u) \in \mathcal{M}_{k}$ then for any boundary of a piecewise smooth bounded domain $U \subseteq \mathbb{R}^{n}$ by Cauchy's Theorem

$$
\begin{equation*}
\int_{\partial U} n(u) p(u) d \sigma(u)=0 \tag{1}
\end{equation*}
$$

Suppose now $a \in \operatorname{Pin}(n+1)$ and $u=a w \tilde{a}$ then although $u \in \mathbb{R}^{n}$ in general $w$ belongs to the hyperplane $a^{-1} \mathbb{R}^{n} \tilde{a}^{-1}$ in $\mathbb{R}^{n+1}$.

By applying a change of variable, up to a sign the integral (1) becomes

$$
\begin{equation*}
\int_{a^{-1} \partial U \tilde{a}^{-1}} a n(w) \tilde{a} P(a w \tilde{a}) d \sigma(w)=0 . \tag{2}
\end{equation*}
$$

As $\partial U$ is arbitrary then on applying Stokes' Theorem to (2) we see that

$$
\begin{equation*}
D_{a} \tilde{a} P(a w \tilde{a})=0, q u a d \text { where } \quad D_{a}:=\left.D_{n+1}\right|_{a^{-1} \mathbb{R}^{n} \tilde{a}^{-1}} \tag{3}
\end{equation*}
$$

Suppose $U$ is a domain in $\mathbb{R}^{n}$. Consider a function of two variables

$$
f: U \times \mathbb{R}^{n} \longrightarrow \mathrm{Cl}_{n+1}
$$

such that for each $x \in U, f(x, u)$ is a left monogenic polynomial homogeneous of degree $k$ in $u$. Let $P_{k}$ be the left projection map

$$
P_{k}: \mathcal{H}_{k} \rightarrow \mathcal{M}_{k},
$$

then $R_{k} f(x, u)$ is defined to be $P_{k} D_{x} f(x, u)$. The left Rarita-Schwinger equation is defined to be

$$
R_{k} f(x, u)=0 .
$$

We also have a right projection $P_{k, r}: \mathcal{H}_{k} \rightarrow \overline{\mathcal{M}_{k}}$, and a right Rarita-Schwinger equation $f(x, u) D_{x} P_{k, r}=f(x, u) R_{k}=0$, where $\overline{\mathcal{M}_{k}}$ stands for the space of right monogenic polynomials homogeneous of degree $k$. See [6].

## 3. Rarita-Schwinger type operators on spheres

Let $\mathbb{R}^{n}$ be the span of $e_{1}, \ldots, e_{n}$. Consider the Cayley transformation $C: \mathbb{R}^{n} \rightarrow$ $\mathbb{S}^{n}$, where $\mathbb{S}^{n}$ is the unit sphere in $\mathbb{R}^{n+1}$, defined by $C(x)=\left(e_{n+1} x+1\right)\left(x+e_{n+1}\right)^{-1}$, where $x=x_{1} e_{1}+\cdots+x_{n} e_{n} \in \mathbb{R}^{n}$, and $e_{n+1}$ is a unit vector in $\mathbb{R}^{n+1}$ which is orthogonal to $\mathbb{R}^{n}$. Now $C\left(\mathbb{R}^{n}\right)=\mathbb{S}^{n} \backslash\left\{e_{n+1}\right\}$. Suppose $x_{s} \in \mathbb{S}^{n}$ and $x_{s}=x_{s_{1}} e_{1}+$ $\cdots+x_{s_{n}} e_{n}+x_{s_{n+1}} e_{n+1}$, then we have $x=C^{-1}\left(x_{s}\right)=\left(-e_{n+1} x_{s}+1\right)\left(x_{s}-e_{n+1}\right)^{-1}$.

The Dirac operator over the $n$-sphere $\mathbb{S}^{n}$ has the form $D_{s}=w\left(\Lambda+\frac{n}{2}\right)$, where $w \in \mathbb{S}^{n}$ and $\Lambda=\sum_{i<j, i=1}^{n} e_{i} e_{j}\left(w_{i} \frac{\partial}{\partial w_{j}}-w_{j} \frac{\partial}{\partial w_{i}}\right)$, see for instance [5, 8, 13].

Let $U$ be a domain in $\mathbb{R}^{n}$. Consider a function $f_{\star}: U \times \mathbb{R}^{n} \rightarrow \mathrm{Cl}_{n+1}$ such that for each $x \in U, f_{\star}(x, u)$ is a left monogenic polynomial homogeneous of degree $k$ in $u$. This function reduces to $f\left(x_{s}, u\right)$ on $C(U) \times \mathbb{R}^{n}$ and $f\left(x_{s}, u\right)$ takes its values in $\mathrm{Cl}_{n+1}$ where $x=C^{-1}\left(x_{s}\right)$ and $x_{s} \in C(U) \subset \mathbb{S}^{n}$. Further $f\left(x_{s}, u\right)$ is a left monogenic polynomial homogeneous of degree $k$ in $u$.

Since $\Delta_{u} D_{s, x_{s}}=D_{s, x_{s}} \Delta_{u}$, then $D_{s, x_{s}} f\left(x_{s}, u\right)$ is harmonic in $u$. Hence by the Almansi-Fischer decomposition:

$$
D_{s, x_{s}} f\left(x_{s}, u\right)=f_{1, k}\left(x_{s}, u\right)+u f_{2, k-1}\left(x_{s}, u\right),
$$

where $f_{1, k}\left(x_{s}, u\right)$ is a left monogenic polynomial homogeneous of degree $k$ in $u$ and $f_{2, k-1}\left(x_{s}, u\right)$ is a left monogenic polynomial homogeneous of degree $k-1$ in $u$.

We can also consider a function $g_{\star}: U \times \mathbb{R}^{n} \rightarrow \mathrm{Cl}_{n+1}$ such that for each $x \in U$, $g_{\star}(x, u)$ is a right monogenic polynomial homogeneous of degree $k$ in $u$. This function also reduces to a right monogenic polynomial homogeneous $g\left(x_{s}, u\right)$ on $C(U) \times \mathbb{R}^{n}$.

Let $P_{k}$ be the left projection map $P_{k}: \mathcal{H}_{k}=\mathcal{M}_{k} \oplus u \mathcal{M}_{k-1} \rightarrow \mathcal{M}_{k}$, then the $n$-spherical left Rarita-Schwinger type operator $R_{k}^{S}$ is defined to be

$$
R_{k}^{S} f\left(x_{s}, u\right)=P_{k} D_{s, x_{s}} f\left(x_{s}, u\right)
$$

On the other hand, the $n$-spherical right Rarita-Schwinger type operator $R_{k, r}^{S}$ is defined to be

$$
g\left(x_{s}, u\right) R_{k, r}^{S}=g\left(x_{s}, u\right) D_{s, x_{s}} P_{k, r}
$$

where $P_{k, r}$ is the right projection $P_{k, r}: \mathcal{H}_{k} \rightarrow \overline{\mathcal{M}}_{k}$. Consequently, the left and the right $n$-spherical Rarita-Schwinger type equations are defined to be

$$
R_{k}^{S} f\left(x_{s}, u\right)=0 \quad \text { and } \quad g\left(x_{s}, u\right) R_{k}^{S}=0 \quad \text { respectively } .
$$

## 4. Conformal invariance of $P_{k}$ under the Cayley transformation AND ITS INVERSE

Consider the Cayley transformation $C(x)=\left(e_{n+1} x+1\right)\left(x+e_{n+1}\right)^{-1}=e_{n+1}(x-$ $\left.e_{n+1}\right)\left(x+e_{n+1}\right)^{-1}=e_{n+1}\left(x+e_{n+1}-2 e_{n+1}\right)\left(x+e_{n+1}\right)^{-1}=e_{n+1}+2\left(x+e_{n+1}\right)^{-1}$. This last term is the Iwasawa decomposition for the Cayley transformation, $C$. Further, $C^{-1}\left(x_{s}\right)=\left(-e_{n+1} x_{s}+1\right)\left(x_{s}-e_{n+1}\right)^{-1}=-e_{n+1}\left(x_{s}+e_{n+1}\right)\left(x-e_{n+1}\right)^{-1}=$ $-e_{n+1}\left(x_{s}-e_{n+1}+2 e_{n+1}\right)\left(x_{s}-e_{n+1}\right)^{-1}=-e_{n+1}+2\left(x_{s}-e_{n+1}\right)^{-1}$, and this last term is the Iwasawa decomposition for the inverse, $C^{-1}$, of the Cayley transformation.

Now let $f\left(x_{s}, u\right): U_{s} \times \mathbb{R}^{n} \rightarrow \mathrm{Cl}_{n+1}$ be a monogenic polynomial homogeneous of degree $k$ in $u$ for each $x_{s} \in U_{s}$, where $U_{s}$ is a domain in $\mathbb{S}^{n}$.

It is shown in [6] that $P_{k}$ is conformally invariant under a general Möbius transformation over $\mathbb{R}^{n}$. This trivially extends to Möbius transformations on $\mathbb{R}^{n+1}$. It follows that if we restrict $x_{s}$ to $\mathbb{S}^{n}$, then $P_{k}$ is also conformally invariant under the Cayley transformation $C$ and its inverse $C^{-1}$, with $x \in \mathbb{R}^{n}$.

It follows that we have:

## Theorem 1.

$$
P_{k, w} J(C, x) f\left(C(x), \frac{\left(x+e_{n+1}\right) w\left(x+e_{n+1}\right)}{\left\|x+e_{n+1}\right\|^{2}}\right)=J(C, x) P_{k, u} f\left(x_{s}, u\right)
$$

where $u=\frac{\left(x+e_{n+1}\right) w\left(x+e_{n+1}\right)}{\left\|x+e_{n+1}\right\|^{2}}$ and $J(C, x)=\frac{x+e_{n+1}}{\left\|x+e_{n+1}\right\|^{n}}$ is the conformal weight for the Cayley transformation.

Also for $U$ a domain in $\mathbb{R}^{n}$, and $g(x, u)$ defined on $U \times \mathbb{R}^{n}$ such that for each $x \in U, g$ is monogenic in $u$ and homogeneous of degree $k$ in $u$, we have:

## Theorem 2.

$$
P_{k, w} J\left(C^{-1}, x_{s}\right) g\left(C^{-1}\left(x_{s}\right), \frac{\left(x_{s}-e_{n+1}\right) w\left(x_{s}-e_{n+1}\right)}{\left\|x_{s}-e_{n+1}\right\|^{2}}\right)=J\left(C^{-1}, x_{s}\right) P_{k, u} g(x, u),
$$

where $u=\frac{\left(x_{s}-e_{n+1}\right) w\left(x_{s}-e_{n+1}\right)}{\left\|x_{s}-e_{n+1}\right\|^{2}}$ and $J\left(C^{-1}, x_{s}\right)=\frac{x_{s}-e_{n+1}}{\left\|x_{s}-e_{n+1}\right\|^{n}}$ is the conformal weight for the inverse Cayley transformation.

Note that in the previous theorems $a_{1}(x):=\frac{x+e_{n+1}}{\left\|x+e_{n+1}\right\|}$ and $a_{2}\left(x_{s}\right):=\frac{x_{s}-e_{n+1}}{\left\|x_{s}-e_{n+1}\right\|}$ belong to $\operatorname{Pin}(n+1)$. So $w \in \mathbb{R}^{n+1}$ and hence $D_{a_{1}(x)} f=0$ and $D_{a_{2}\left(x_{s}\right)} g=0$, where for $a \in \operatorname{Pin}(n+1)$ the operator $D_{a}$ is defined in (3).
5. The intertwining formulas for $R_{k}$ and $R_{k}^{S}$ and the conformal INVARIANCE OF $R_{k}^{S} f=0$
We can use the intertwining formulas for $D_{x}$ and $D_{s, x_{s}}$ given in [8 to establish the intertwining formulas for $R_{k}$ and $R_{k}^{S}$.

## Theorem 3.

$$
\begin{aligned}
& J_{-1}\left(C^{-1}, x_{s}\right) R_{k, u} f(x, u) \\
& \qquad=R_{k, w}^{S} J\left(C^{-1}, x_{s}\right) f\left(C^{-1}\left(x_{s}\right), \frac{\left(x_{s}-e_{n+1}\right) w\left(x_{s}-e_{n+1}\right)}{\left\|x_{s}-e_{n+1}\right\|^{2}}\right),
\end{aligned}
$$

where $R_{k, u}$ is the Rarita-Schwinger operator in Euclidean space with respect to $u \in \mathbb{R}^{n}, R_{k, w}^{S}$ is the spherical Rarita-Schwinger type operator on $\mathbb{S}^{n}$ with respect to $w \in \mathbb{R}^{n+1}, u=\frac{\left(x_{s}-e_{n+1}\right) w\left(x_{s}-e_{n+1}\right)}{\left\|x_{s}-e_{n+1}\right\|^{2}}, J\left(C^{-1}, x_{s}\right)=\frac{x_{s}-e_{n+1}}{\left\|x_{s}-e_{n+1}\right\|^{n}}$ and $J_{-1}\left(C^{-1}, x_{s}\right)=\frac{x_{s}-e_{n+1}}{\left\|x_{s}-e_{n+1}\right\|^{n+2}}$.

Proof. In [8] it is shown that $D_{x}=J_{-1}\left(C^{-1}, x_{s}\right)^{-1} D_{s, x_{s}} J\left(C^{-1}, x_{s}\right)$. Consequently, $R_{k, u} f(x, u)=P_{k, u} D_{x} f(x, u)=P_{k, u} J_{-1}\left(C^{-1}, x_{s}\right)^{-1} D_{s, x_{s}} J\left(C^{-1}, x_{s}\right) f\left(C^{-1}\left(x_{s}\right), u\right)$. Now applying Theorem 2 the previous equation becomes

\begin{aligned}
R_{k, u} f(x, u)= & J_{-1}\left(C^{-1}, x_{s}\right)^{-1} P_{k, w} D_{s, x_{s}} J\left(C^{-1}, x_{s}\right) \\
& \times f\left(C^{-1}\left(x_{s}\right), \frac{\left(x_{s}-e_{n+1}\right) w\left(x_{s}-e_{n+1}\right)}{\left\|x_{s}-e_{n+1}\right\|^{2}}\right) \\
= & J_{-1}\left(C^{-1}, x_{s}\right)^{-1} R_{k, w}^{S} J\left(C^{-1}, x_{s}\right) \\
& \times f\left(C^{-1}\left(x_{s}\right), \frac{\left(x_{s}-e_{n+1}\right) w\left(x_{s}-e_{n+1}\right)}{\left\|x_{s}-e_{n+1}\right\|^{2}}\right) .
\end{aligned}
$$

We have the similar result for the Rarita-Schwinger operator under the Cayley transformation.

## Theorem 4.

$$
J_{-1}(C, x) R_{k, u}^{S} g\left(x_{s}, u\right)=R_{k, w} J(C, x) g\left(C(x), \frac{\left(x+e_{n+1}\right) w\left(x+e_{n+1}\right)}{\left\|x+e_{n+1}\right\|^{2}}\right)
$$

where $R_{k, u}^{S}$ is the Rarita-Schwinger type operator on the sphere with respect to $u$ and $R_{k, w}$ is the Rarita-Schwinger operator in Euclidean space with respect to $w$,

$$
\begin{aligned}
u & =\frac{\left(x+e_{n+1}\right) w\left(x+e_{n+1}\right)}{\left\|x+e_{n+1}\right\|^{2}}, \quad J(C, x)=\frac{x+e_{n+1}}{\left\|x+e_{n+1}\right\|^{n}} \quad \text { and } \\
J_{-1}(C, x) & =\frac{x+e_{n+1}}{\left\|x+e_{n+1}\right\|^{n+2}} .
\end{aligned}
$$

In other words we have the following intertwining relations for $R_{k}$ and $R_{k}^{S}$ :

As a corollary to Theorems 3 and 4 we have the conformal invariance of equation $R_{k, w}^{S} f=0$ :

6. The fundamental solutions of $R_{k}^{S}$ and some basic integral FORMULAS

The reproducing kernel of $\mathcal{M}_{k}$ with respect to integration over $\mathbb{S}^{n-1}$ is given by (see [2], [6])

$$

where

P_{\sigma}(u)=\frac{1}{k!} \Sigma\left(u_{i_{1}}-u_{1} e_{1}^{-1} e_{i_{1}}\right) \ldots\left(u_{i_{k}}-u_{1} e_{1}^{-1} e_{i_{k}}\right), V_{\sigma}(v)=\frac{\partial^{k} G(v)}{\partial v_{2}^{j_{2}} \ldots \partial v_{n}^{j_{n}}},
$$

$j_{2}+\cdots+j_{n}=k, i_{k} \in\{2, \ldots, n\}, G(v)=\frac{-1}{\omega_{n}} \frac{v}{\|v\|^{n}}$, and $\omega_{n}$ is the surface area of the unit sphere in $\mathbb{R}^{n}$. Here summation is taken over all permutations of the monomials without repetition. This function is left monogenic in $u$ and it is a right monogenic polynomial in $v$. It is homogeneous of degree $k$ in both $u$ and $v$. See [2] and elsewhere.

Consider the kernel of the Rarita-Schwinger operator in Euclidean $n$-space

\end{align*}

where $c_{k}=\frac{n-2}{n-2+2 k}$. See for instance [6]. Note that $(x-y) u(x-y) \in \mathbb{R}^{n}$ as $u$, $x$ and $y \in \mathbb{R}^{n}$.

Now applying the Cayley transformation to the above kernel, we obtain

where $a=a\left(x_{s}, y_{s}\right)=\frac{J\left(C^{-1}, x_{s}\right)^{-1}\left(x_{s}-y_{s}\right) J\left(C^{-1}, y_{s}\right)^{-1}}{\left\|J\left(C^{-1}, x_{s}\right)^{-1}\right\|\left\|\left(x_{s}-y_{s}\right)\right\|\left\|J\left(C^{-1}, y_{s}\right)^{-1}\right\|}$.
$E_{k}^{S}\left(x_{s}, y_{s}, u, v\right)$ is the fundamental solution to $R_{k}^{S} f\left(x_{s}, u\right)=0$ on $\mathbb{S}^{n}$. This function is left monogenic in $u$ and it is also right monogenic in $v$.

In the same way we obtain that

is a non trivial solution to $g\left(x_{s}, v\right) R_{k, r}^{S}=0$. In fact, this function is $E_{k}^{S}\left(x_{s}, y_{s}, u, v\right)$.
Applying the same arguments in [6] to prove the representations (8) and (9) are the same up to a reflection, we have

& =-\frac{1}{\omega_{n} c_{k}} J\left(C^{-1}, y_{s}\right)^{-1} \frac{x_{s}-y_{s}}{\left\|x_{s}-y_{s}\right\|^{n}} \frac{J\left(C^{-1}, x_{s}\right)^{-1}}{\left\|J\left(C^{-1}, x_{s}\right)^{-1}\right\|} Z_{k}(a u \tilde{a}, v) \frac{J\left(C^{-1}, x_{s}\right)^{-1}}{\left\|J\left(C^{-1}, x_{s}\right)^{-1}\right\|} \\
& =-\frac{J\left(C^{-1}, x_{s}\right)^{-1}}{\left\|J\left(C^{-1}, x_{s}\right)^{-1}\right\|} \frac{1}{\omega_{n} c_{k}} \frac{x_{s}-y_{s}}{\left\|x_{s}-y_{s}\right\|^{n}} J\left(C^{-1}, y_{s}\right)^{-1} Z_{k}(a u \tilde{a}, v) \frac{J\left(C^{-1}, x_{s}\right)^{-1}}{\left\|J\left(C^{-1}, x_{s}\right)^{-1}\right\|}
\end{aligned}
$$

Theorem 6 (Stokes' Theorem for the $n$-spherical Dirac operator $D_{s}$ [8]). Suppose $U_{s}$ is a domain on $\mathbb{S}^{n}$ and $f, g: U_{s} \times \mathbb{R}^{n} \rightarrow \mathrm{Cl}_{n+1}$ are $C^{1}$, then for $\partial V_{s}$ a sufficiently smooth hypersurface in $U_{s}$ bounding a subdomain $V_{s}$ of $U_{s}$, we have

\end{aligned}

where $d S\left(x_{s}\right)$ is the n-dimensional area measure on $V_{s}, d \Sigma\left(x_{s}\right)$ is the $n$-1-dimensional scalar Lebesgue measure on $\partial V_{s}$ and $n\left(x_{s}\right)$ is the normal vector tangent to the sphere at $x_{s}$, orthogonal to $\partial V_{s}$ and pointing outward.

Definition 1 (6). For any $\mathrm{Cl}_{n+1}$-valued polynomials $P(u), Q(u)$, the inner product $(P(u), Q(u))_{u}$ with respect to $u \in \mathbb{R}^{n}$ is given by

where $\mathbb{S}^{n-1}$ is the unit sphere in $\mathbb{R}^{n}$.

Theorem 7 (Stokes' Theorem for the $n$-spherical Rarita-Schwinger type operator $\left.R_{k}^{S}\right)$. Let $U_{s}, V_{s}, \partial V_{s}$ be as in Theorem 6. Then for $f, g \in C^{1}\left(U_{s} \times \mathbb{R}^{n}, \mathcal{M}_{k}\right)$, we have

= & \int_{\partial V_{s}}\left(g\left(x_{s}, u\right) n\left(x_{s}\right) P_{k, r}, f\left(x_{s}, u\right)\right)_{u} d \Sigma\left(x_{s}\right) \\
= & \int_{\partial V_{s}}\left(g\left(x_{s}, u\right) n\left(x_{s}\right) f\left(x_{s}, u\right)\right)_{u} d \Sigma\left(x_{s}\right)
\end{aligned}

where $d S\left(x_{s}\right)$ is the $n$-dimensional area measure on $V_{s}, n\left(x_{s}\right)$ and $d \Sigma\left(x_{s}\right)$ are as in Theorem 6 .

Proof. The proof follows similar lines to the proof of Theorem 6 in 6]. First, by the traditional Clifford version of Stokes' Theorem

By applying the Almansi-Fischer decomposition to $g\left(x_{s}, u\right) D_{s, x_{s}}$ and $D_{s, x_{s}} f\left(x_{s}, u\right)$ and Definition 1 the right side of the previous equation becomes

Now let us look at Stokes' Theorem for Rarita-Schwinger operators $R_{k}$ in $\mathbb{R}^{n}$. Suppose $U$ is a domain on $\mathbb{R}^{n}$ and $f_{\star}, g_{\star}: U \times \mathbb{R}^{n} \rightarrow \mathrm{Cl}_{n+1}$ are $C^{1}$, then for $\partial V$ a sufficiently smooth hypersurface in $U$ bounding a relatively compact subdomain $V$ of $U$, we have

& =\int_{\partial V}\left(g_{\star}(x, u), P_{k} n(x) f_{\star}(x, u)\right)_{u} d \sigma(x)
\end{aligned}
$$

where $d \sigma(x)$ is the scalar Lebesgue measure on $\partial V$. Now consider the integral on the right hand side

& \times J\left(C^{-1}, x_{s}\right) f_{\star}\left(C^{-1}\left(x_{s}\right), u\right) d s(u) d \Sigma\left(x_{s}\right),

where $x_{s}=C(x), C(\partial V)$ bounds a domain $C(V)$ in $\mathbb{S}^{n}, d \Sigma\left(x_{s}\right)$ is the scalar Lebesgue measure on $C(\partial V)$ and $J\left(C^{-1}, x_{s}\right)=\frac{x_{s}-e_{n+1}}{\left\|x_{s}-e_{n+1}\right\|^{n}}$. Since $P_{k, u}$ interchanges with $J\left(C^{-1}, x_{s}\right)$, the previous integral becomes

where $u=\frac{\left(x_{s}-e_{n+1}\right) w\left(x_{s}-e_{n+1}\right)}{\left\|x_{s}-e_{n+1}\right\|^{2}}$.
Consider the integral on the left hand side

& +g_{\star}\left(C^{-1}\left(x_{s}\right), \frac{\left(x_{s}-e_{n+1}\right) w\left(x_{s}-e_{n+1}\right)}{\left\|x_{s}-e_{n+1}\right\|^{2}}\right) J\left(C^{-1}, x_{s}\right) R_{k, w}^{S} J\left(C^{-1}, x_{s}\right) \\

where $C(V)=V_{s}$ is a domain in $\mathbb{S}^{n}$.
Stokes' Theorem for Rarita-Schwinger operators $R_{k}$ in $\mathbb{R}^{n}$ tells us that 10 is equal to (12). Therefore Stokes' Theorem for Rarita-Schwinger type operators is conformally invariant under the Cayley transformation.

Now let us consider Stokes' Theorem for $R_{k}^{S}$ in $\mathbb{S}^{n}$.

where $V_{s}, \partial V_{s}, d S\left(x_{s}\right)$ and $d \Sigma\left(x_{s}\right)$ are stated as in Theorem 7
First look at

where $J(C, x)=\frac{x+e_{n+1}}{\left\|x+e_{n+1}\right\|^{n}}, x=C^{-1}\left(x_{s}\right)$ and $C^{-1}\left(\partial V_{s}\right)$ bounds a domain $C^{-1}\left(V_{s}\right)$ in $\mathbb{R}^{n}$. Since we can interchange $P_{k, u}$ with $J(C, x)$, the previous integral is equal to

& \times R_{k, w}^{S} J(C, x) f\left(C(x), \frac{\left(x+e_{n+1}\right) w\left(x+e_{n+1}\right)}{\left\|x+e_{n+1}\right\|^{2}}\right) d s(w) d S\left(x_{s}\right) .

Stokes' Theorem for $R_{k}^{S}$ on the sphere shows that 13 is equal to (14). Thus Stokes' Theorem for Rarita-Schwinger operators is also conformally invariant under the inverse of the Cayley transformation.

Theorem 8 (Borel-Pompeiu Theorem). Suppose $U_{s}, V_{s}$ and $\partial V_{s}$ are as in Theorem $\sqrt{6}$ and $y_{s} \in V_{s}$. Then for $f \in C^{1}\left(U_{s} \times \mathbb{R}^{n}, \mathcal{M}_{k}\right)$ we have

& -J\left(C^{-1}, y_{s}\right) \int_{V_{s}}\left(E_{k}^{S}\left(x_{s}, y_{s}, u, v\right), R_{k}^{S} f\left(x_{s}, v\right)\right)_{v} d S\left(x_{s}\right)
\end{aligned}
$$

where $u^{\prime}=\frac{J\left(C^{-1}, y_{s}\right)^{-1} u J\left(C^{-1}, y_{s}\right)^{-1}}{\left\|J\left(C^{-1}, y_{s}\right)^{-1}\right\|^{2}}, d S\left(x_{s}\right)$ is the $n$-dimensional area measure on $V_{s} \subset \mathbb{S}^{n}, n\left(x_{s}\right)$ and $d \Sigma\left(x_{s}\right)$ are as in Theorem 6 .

Proof. In this proof we will use the representation of $E_{k}^{S}\left(x_{s}, y_{s}, u, v\right)$ given by (9).
Let $B_{s}\left(y_{s}, \epsilon\right)$ be the ball centered at $y_{s} \in \mathbb{S}^{n}$ with radius $\epsilon$.
We denote $C^{-1}\left(B_{s}\left(y_{s}, \epsilon\right)\right)$ by $B(y, r)$, and $C^{-1}\left(\partial B_{s}\left(y_{s}, \epsilon\right)\right)$ by $\partial B(y, r)$, where $y=C^{-1}\left(y_{s}\right) \in \mathbb{R}^{n}$ and $r$ is the radius of $B(y, r)$ in $\mathbb{R}^{n}$. Consider $\bar{B}_{s}\left(y_{s}, \epsilon\right) \subset V_{s}$, then we have

& +\int_{B_{s}\left(y_{s}, \epsilon\right)}\left(E_{k}^{S}\left(x_{s}, y_{s}, u, v\right), R_{k}^{S} f\left(x_{s}, v\right)\right)_{v} d S\left(x_{s}\right) .
\end{aligned}

Because of the degree of homogeneity of $x_{s}-y_{s}$ in $E_{k}^{S}$, the second integral on the right hand goes to zero as $\epsilon$ goes to zero. Applying Theorem 7 to the first integral on the right hand we obtain

&-\int_{\partial B_{s}\left(y_{s}, \epsilon\right)}\left(E_{k}^{S}\left(x_{s}, y_{s}, u, v\right), P_{k} n\left(x_{s}\right) f\left(x_{s}, v\right)\right)_{v} d \Sigma\left(x_{s}\right)
\end{aligned}
$$

Since $f\left(x_{s}, v\right)=\left(f\left(x_{s}, v\right)-f\left(y_{s}, v\right)\right)+f\left(y_{s}, v\right)$ and taking into account the degree of homogeneity of $x_{s}-y_{s}$ in $E_{k}^{S}$ and the continuity of $f$, we can replace the second integral on the right hand by

= & \int_{\partial B_{s}\left(y_{s}, \epsilon\right)} \int_{\mathbb{S}^{n-1}} E_{k}^{S}\left(x_{s}, y_{s}, u, v\right) n\left(x_{s}\right) f\left(y_{s}, v\right) d \Sigma\left(x_{s}\right) d s(v) \\
= & \int_{\partial B_{s}\left(y_{s}, \epsilon\right)} \int_{\mathbb{S}^{n-1}} \frac{1}{\omega_{n} c_{k}} Z_{k}(u, \tilde{a} v a) \\
& \times J\left(C^{-1}, y_{s}\right)^{-1} \frac{x_{s}-y_{s}}{\left\|x_{s}-y_{s}\right\|^{n}} n\left(x_{s}\right) f\left(y_{s}, v\right) d s(v) d \Sigma\left(x_{s}\right)
\end{aligned}
$$

Now applying the inverse of the Cayley transformation to the last integral, we have

\int_{\partial B(y, r)} & \int_{\mathbb{S}^{n-1}} \frac{1}{\omega_{n} c_{k}} Z_{k}\left(u, \frac{(x-y) w(x-y)}{\|x-y\|^{2}}\right) J\left(C^{-1}, y_{s}\right)^{-1} J(C, y)^{-1} \frac{x-y}{\|x-y\|^{n}} \\
& \times J(C, x)^{-1} J(C, x) n(x) J(C, x) f\left(C(y), \frac{J(C, y) w J(C, y)}{\|J(C, y)\|^{2}}\right) d s(w) d \sigma(x)
\end{aligned}
$$

where $d \sigma(x)$ is the $n$-1-dimensional scalar Lebesgue measure on $\partial B(y, r)$ in $\mathbb{R}^{n}$ and $v=\frac{J(C, y) w J(C, y)}{\|J(C, y)\|^{2}}, w \in \mathbb{R}^{n+1}$. In fact, $v$ is a vector in $\mathbb{R}^{n}$ which is obtained by reflecting $w$ in $\mathbb{R}^{n+1}$ and its last component is a constant.

Place $J(C, x)=(J(C, x)-J(C, y))+J(C, y)$, but $J(C, x)-J(C, y)$ tends to zero as $x$ approaches $y$. Thus the previous integral can be replaced by

& \times J(C, y) f\left(C(y), \frac{J(C, y) w J(C, y)}{\|J(C, y)\|^{2}}\right) d s(w) d \sigma(x)

Here $n(x)=\frac{y-x}{\|x-y\|}$ is the unit out normal vector. Now the last integral becomes

Using Lemma 5 in [6], the integral is now

& \quad=J\left(C^{-1}, y_{s}\right)^{-1} f\left(y_{s}, \frac{J\left(C^{-1}, y_{s}\right)^{-1} u J\left(C^{-1}, y_{s}\right)^{-1}}{\left\|J\left(C^{-1}, y_{s}\right)^{-1}\right\|^{2}}\right)
\end{aligned}
$$

since $J(C, y)=J\left(C^{-1}, y_{s}\right)^{-1}$.
Now by setting $u^{\prime}=\frac{J\left(C^{-1}, y_{s}\right)^{-1} u J\left(C^{-1}, y_{s}\right)^{-1}}{\left\|J\left(C^{-1}, y_{s}\right)^{-1}\right\|^{2}}$ and multiplying both sides of the above equation by $J\left(C^{-1}, y_{s}\right)$, we obtain

Corollary 3 (Cauchy Integral Formula for $R_{k}^{S}$ ). If $R_{k}^{S} f\left(x_{s}, u\right)=0$, then for $y_{s} \in V_{s}$ we have

& =J\left(C^{-1}, y_{s}\right) \int_{\partial V_{s}}\left(E_{k}^{S}\left(x_{s}, y_{s}, u, v\right) n\left(x_{s}\right) P_{k, r}, f\left(x_{s}, v\right)\right)_{v} d \Sigma\left(x_{s}\right)
\end{aligned}
$$

where $u^{\prime}=\frac{J\left(C^{-1}, y_{s}\right)^{-1} u J\left(C^{-1}, y_{s}\right)^{-1}}{\left\|J\left(C^{-1}, y_{s}\right)^{-1}\right\|^{2}}$.
Definition 2 (Cauchy Transform for $R_{k}^{S}$ ). For a domain $V_{s} \subset \mathbb{S}^{n}$ and a function $f\left(x_{s}, u\right): V_{s} \times \mathbb{R}^{n} \rightarrow \mathrm{Cl}_{n+1}$, which is monogenic in $u$, the $T_{k}$-transform of $f$ is defined to be

$$

Theorem 9. For a function $\psi$ in $C^{\infty}\left(\mathbb{S}^{n} \times \mathbb{R}^{n}, \mathcal{M}_{k}\right)$ we have

Proof. By [8], the integral

can be replaced by

$$

which in turn is equal to

P_{k} J\left(C^{-1}, y_{s}\right) & \int_{\partial B_{s}\left(y_{s}, \epsilon\right)} \int_{\mathbb{S}^{n-1}}-n\left(x_{s}\right) \frac{1}{\omega_{n} c_{k}} \frac{x_{s}-y_{s}}{\left\|x_{s}-y_{s}\right\|^{n}} \\
& \times J\left(C^{-1}, y_{s}\right)^{-1} Z_{k}(a u \tilde{a}, v) \psi\left(x_{s}, u\right) d s(u) d S\left(x_{s}\right) .
\end{aligned}
$$

Since $\psi\left(x_{s}, u\right)=\psi\left(x_{s}, u\right)-\psi\left(y_{s}, u\right)+\psi\left(y_{s}, u\right)$ then using the continuity of $\psi$, we can replace the previous integral by

Now applying the inverse of the Cayley transformation to the previous integral it becomes

& \times Z_{k}\left(\frac{(x-y) u(x-y)}{\|x-y\|^{2}}, v\right) \psi\left(C(y), \frac{J(C, y) w J(C, y)}{\|J(C, y)\|^{2}}\right) d s(u) d \sigma(x) \\
= & P_{k} J\left(C^{-1}, y_{s}\right) \int_{\partial B(y, r)} \int_{\mathbb{S}^{n-1}}-J(C, x) n(x) \frac{1}{\omega_{n} c_{k}} \frac{x-y}{\|x-y\|^{n}} \\
& \times Z_{k}\left(\frac{(x-y) u(x-y)}{\|x-y\|^{2}}, v\right) \psi\left(C(y), \frac{J(C, y) w J(C, y)}{\|J(C, y)\|^{2}}\right) d s(u) d \sigma(x)
\end{aligned}
$$

where $u=\frac{J(C, y) w J(C, y)}{\|J(C, y)\|^{2}}$.
Using the fact $J(C, x)=(J(C, x)-J(C, y))+J(C, y)$, and $J(C, x)-J(C, y)$ tends to zero as $x$ approaches $y$, the integral can be replaced by

= & P_{k} \int_{\partial B(y, r)} \int_{\mathbb{S}^{n-1}} \frac{1}{\omega_{n} c_{k} r^{n-1}} Z_{k}\left(\frac{(x-y) u(x-y)}{\|x-y\|^{2}}, v\right) \\
& \times \psi\left(C(y), \frac{J(C, y) w J(C, y)}{\|J(C, y)\|^{2}}\right) d s(u) d \sigma(x)
\end{aligned}
$$

Applying Lemma 5 in [6], the integral becomes

## 7. Rarita-Schwinger type operators on real projective space

We consider $\mathbb{S}^{n}$ and $\Gamma=\{ \pm 1\}$, then $\mathbb{S}^{n} / \Gamma$ is $\mathbb{R} P^{n}$, the real projective space. In all that follows $\mathbb{S}^{n}$ will be a universal covering space of the conformally flat manifold $\mathbb{R} P^{n}$. So there is a projection map $p: \mathbb{S}^{n} \rightarrow \mathbb{R} P^{n}$. Further for each $x \in \mathbb{S}^{n}$ we shall denote $p(x)$ by $x^{\prime}$. Furthermore if $Q$ is a subset of $U$ then we denote $p(Q)$ by $Q^{\prime}$.

Consider the trivial bundle $\mathbb{S}^{n} \times \mathrm{Cl}_{n+1}$, then we set up a spinor bundle $E_{1}$ over $\mathbb{R} P^{n}$ by making the identification of $(x, X)$ with $(-x, X)$, where $x \in \mathbb{S}^{n}$ and $X \in \mathrm{Cl}_{n+1}$.

Now we change the spherical Cauchy kernel $G_{S}(x-y)=\frac{-1}{\omega_{n}} \frac{x-y}{\|x-y\|^{n}}, x, y \in \mathbb{S}^{n}$, for the spherical Dirac operator into a kernel which is invariant with respect to $\{ \pm 1\}$ in the variable $x \in \mathbb{S}^{n}$. Hence we consider $G_{S}(x-y)+G_{S}(-x-y)$. See [7].

Suppose $V$ is a domain lying in the open northern hemisphere. We assume

$$
f(x, u): V \times \mathbb{R}^{n} \rightarrow \mathrm{Cl}_{n+1}
$$

is a $C^{1}$ function in $x$ and monogenic in $u$. We observe that the projection map $p: \mathbb{S}^{n} \rightarrow \mathbb{R} P^{n}$ induces a well defined function

$$
f^{\prime}\left(x^{\prime}, u\right): V^{\prime} \times \mathbb{R}^{n} \rightarrow E_{1}
$$

such that $f^{\prime}\left(x^{\prime}, u\right)=f\left(p^{-1}\left(x^{\prime}\right), u\right)$, where $V^{\prime}$ is a well defined domain in $\mathbb{R} P^{n}$ and $x^{\prime}=p(x)$.

We define the Rarita-Schwinger type operators on $\mathbb{R} P^{n}$, which we will call the real projective Rarita-Schwinger type operators, in the following form

$$
R_{k}^{R P^{n}} f^{\prime}\left(x^{\prime}, u\right)=P_{k} D_{R P^{n}, x^{\prime}} f^{\prime}\left(x^{\prime}, u\right),
$$

where $D_{R P^{n}, x^{\prime}}$ is the Dirac operator in $\mathbb{R} P^{n}$ with respect to the variable $x^{\prime}$. See [7].

Now we introduce the spherical Rarita-Schwinger kernel which is also invariant with respect to $\{ \pm 1\}$ in the variable $x \in \mathbb{S}^{n}$ :

\mathcal{E}_{k}^{S, 1}(x, y, u, v):=E_{k}^{S}(x, y, u, v)+E_{k}^{S}(-x, y, u, v) .
$$

Through the projection map $p$ (over $x, y \in \mathbb{S}^{n}$ ) we obtain a kernel $\mathcal{E}_{k}^{R P^{n}, 1}\left(x^{\prime}, y^{\prime}, u, v\right)$ for $\mathbb{R} P^{n}$ defined by

$$
\mathcal{E}_{k}^{R P^{n}, 1}\left(x^{\prime}, y^{\prime}, u, v\right)=\mathcal{E}_{k}^{S, 1}\left(p^{-1}\left(x^{\prime}\right), p^{-1}\left(y^{\prime}\right), u, v\right)
$$

Now suppose that $S$ is a suitably smooth hypersurface lying in the open northern hemisphere of $\mathbb{S}^{n}$ bounding a subdomain $W$ of $V$ with closure of $W$ in $V$.

Theorem 10. If $R_{k}^{S} f(x, u)=0$ then for $y \in W$

f(y, w)=J\left(C^{-1}, y\right) \int_{S}\left(\mathcal{E}_{k}^{S, 1}(x, y, u, v), P_{k} n(x) f(x, u)\right)_{u} d \Sigma(x)
$$

where $w=\frac{J\left(C^{-1}, y\right)^{-1} v J\left(C^{-1}, y\right)^{-1}}{\left\|J\left(C^{-1}, y\right)^{-1}\right\|^{2}}, n(x)$ is the unit outer normal vector to $S$ at $x$ lying in the tangent space of $S^{n}$ at $x$ and $\Sigma$ is the usual Lebesgue measure on $S$.

Due to the projection map we have also

## Theorem 11.

$$
f^{\prime}\left(y^{\prime}, \hat{v}\right)=J\left(C^{-1}, y^{\prime}\right) \int_{S^{\prime}}\left(\mathcal{E}_{k}^{R P^{n}, 1}\left(x^{\prime}, y^{\prime}, u, v\right), P_{k} d p(n(x)) f^{\prime}\left(x^{\prime}, u\right)\right)_{u} d \Sigma^{\prime}\left(x^{\prime}\right)
$$

where $\hat{v}=\frac{J\left(C^{-1}, y^{\prime}\right)^{-1} v J\left(C^{-1}, y^{\prime}\right)^{-1}}{\left\|J\left(C^{-1}, y^{\prime}\right)^{-1}\right\|^{2}}, x^{\prime}=p(x), y^{\prime}=p(y)$ and $S^{\prime}$ is the projection of $S$. Further $\Sigma^{\prime}$ is a induced measure on $S^{\prime}$ from the measure $\Sigma$ on $S$ and $d p$ is the derivative of $p$.

Now we will assume that the domain $V$ is such that $-x \in V$ for each $x \in V$ and the function $f$ is two fold periodic, so that $f(x)=f(-x)$. Now the projection map $p$ gives rise to a well defined domain $V^{\prime}$ on $\mathbb{R} P^{n}$ and a well defined function $f^{\prime}\left(x^{\prime}, u\right): V^{\prime} \rightarrow E_{1}$ such that $f^{\prime}\left(x^{\prime}, u\right)=f( \pm x, u)$ for $p( \pm x)=x^{\prime}$. Then if $R_{k}^{R P^{n}} f^{\prime}\left(x^{\prime}, u\right)=0$, we also have

$$
f^{\prime}\left(y^{\prime}, \hat{v}\right)=J\left(C^{-1}, y^{\prime}\right) \int_{S^{\prime}}\left(\mathcal{E}_{k}^{R P^{n}, 1}\left(x^{\prime}, y^{\prime}, u, v\right), P_{k} d p(n(x)) f^{\prime}\left(x^{\prime}, u\right)\right)_{u} d \Sigma^{\prime}\left(x^{\prime}\right)
$$

where $\hat{v}$ is stated as in Theorem 11
If now we suppose that the hypersurface $S$ satisfies $-S=S$ then both $y$ and $-y$ belong to the subdomain $V$ and in this case

$$
J\left(C^{-1}, y^{\prime}\right) \int_{S^{\prime}}\left(\mathcal{E}_{k}^{R P^{n}, 1}\left(x^{\prime}, y^{\prime}, u, v\right), P_{k} d p(n(x)) f^{\prime}\left(x^{\prime}, u\right)\right)_{u} d \Sigma^{\prime}\left(x^{\prime}\right)=2 f^{\prime}\left(y^{\prime}, \hat{v}\right)
$$

We can also construct a second spinor bundle $E_{2}$ over $\mathbb{R} P^{n}$ by making the identification of $(x, X)$ with $(-x,-X)$, where $x \in \mathbb{S}^{n}$ and $X \in \mathrm{Cl}_{n+1}$, we introduce the kernel:

$$
\mathcal{E}_{k}^{S, 2}(x, y, u, v):=E_{k}^{S}(x, y, u, v)-E_{k}^{S}(-x, y, u, v)
$$

This kernel induces through the projection map on the variable $x, y \in \mathbb{S}^{n}$, the kernel on $\mathbb{R} P^{n}$

$$
\mathcal{E}_{k}^{R P^{n}, 2}\left(x^{\prime}, y^{\prime}, u, v\right)=\mathcal{E}_{k}^{S, 2}\left(p^{-1}\left(x^{\prime}\right), p^{-1}\left(y^{\prime}\right), u, v\right)
$$

In this case a solution of Rarita-Schwinger type equation on $\mathbb{R} P^{n}$

$$
f^{\prime}\left(x^{\prime}, u\right): V^{\prime} \times \mathbb{R}^{n} \rightarrow E_{2}
$$

will lift to a solution of spherical-Rarita-Schwinger type equation: $f(x, u): V \times \mathbb{R}^{n} \rightarrow$ $\mathrm{Cl}_{n+1}$ such that $f(x, u)=-f(-x, u)$.

Suppose that $V$ as before is a domain on $\mathbb{S}^{n}$ and $S$ is a hypersurface in $V$ bounding a subdomain $W$ of $V$. Suppose further that $f(x, u): V \times \mathbb{R}^{n} \rightarrow \mathrm{Cl}_{n+1}$ is a solution of the spherical Rarita-Schwinger type equation such that $f(x, u)=-f(-x, u)$. If $S$ lies entirely in one open hemisphere then

$$
f(y, w)=J\left(C^{-1}, y\right) \int_{S}\left(\mathcal{E}_{k}^{S, 2}(x, y, u, v), P_{k} n(x) f(x, u)\right)_{u} d \Sigma(x)
$$

for each $y \in W$, where $w=\frac{J\left(C^{-1}, y\right)^{-1} v J\left(C^{-1}, y\right)^{-1}}{\left\|J\left(C^{-1}, y\right)^{-1}\right\|^{2}}$.
Via the projection $p$ this integral formula induces the following

$$
f^{\prime}\left(y^{\prime}, \hat{v}\right)=J\left(C^{-1}, y^{\prime}\right) \int_{S^{\prime}}\left(\mathcal{E}_{k}^{R P^{n}, 2}\left(x^{\prime}, y^{\prime}, u, v\right), P_{k} d p(n(x)) f^{\prime}\left(x^{\prime}, u\right)\right)_{u} d \Sigma^{\prime}\left(x^{\prime}\right)
$$

where $\hat{v}$ is stated as in Theorem 11
On the other hand if $S$ is such that $S=-S$ then

$$
\int_{S}\left(\mathcal{E}_{k}^{S, 2}(x, y, u, v), P_{k} n(x) f(x, u)\right)_{u} d \Sigma(x)=0
$$
