# The Method of Subsuper Solutions for Weighted $p(r)$-Laplacian Equation Boundary Value Problems

This paper investigates the existence of solutions for weighted $p(r)$-Laplacian ordinary boundary value problems. Our method is based on Leray-Schauder degree. As an application, we give the existence of weak solutions for $p(x)$-Laplacian partial differential equations.

## 1. Introduction

In this paper, we consider the existence of solutions for the following weighted $p(r)$-Laplacian ordinary equation with right-hand terms depending on the first-order derivative:

with one of the following boundary value conditions:

g\left(u\left(T_{1}\right),\left(w\left(T_{1}\right)\right)^{1 /\left(p\left(T_{1}\right)-1\right)} u^{\prime}\left(T_{1}\right)\right)=0, \quad h\left(u\left(T_{2}\right),\left(w\left(T_{2}\right)\right)^{1 /\left(p\left(T_{2}\right)-1\right)} u^{\prime}\left(T_{2}\right)\right)=0,  \tag{1.3}\\
u\left(T_{1}\right)=u\left(T_{2}\right), \quad w\left(T_{1}\right)\left|u^{\prime}\left(T_{1}\right)\right|^{p\left(T_{1}\right)-2} u^{\prime}\left(T_{1}\right)=w\left(T_{2}\right)\left|u^{\prime}\left(T_{2}\right)\right|^{p\left(T_{2}\right)-2} u^{\prime}\left(T_{2}\right), \tag{1.4}

where $p \in C\left(\left[T_{1}, T_{2}\right], \mathbb{R}\right)$ and $p(r)>1 ; w \in C\left(\left[T_{1}, T_{2}\right], \mathbb{R}\right)$ satisfies $0<w(r), \forall r \in\left(T_{1}, T_{2}\right)$, and $(w(r))^{-1 /(p(r)-1)} \in L^{1}\left(T_{1}, T_{2}\right) ;-\left(w(r)\left|u^{\prime}\right|^{p(r)-2} u^{\prime}\right)^{\prime}$ is called the weighted $p(r)$-Laplacian; the
notation $\left(w\left(T_{1}\right)\right)^{1 /\left(p\left(T_{1}\right)-1\right)} u^{\prime}\left(T_{1}\right)$ means $\lim _{r \rightarrow T_{1}^{+}}(w(r))^{1 /(p(r)-1)} u^{\prime}(r)$ exists and

similarly

where $g(x, y)$ and $h(x, y)$ are continuous and increasing in $y$ for any fixed $x$, respectively.
The study of differential equations and variational problems with nonstandard $p(r)-$ growth conditions is a new and interesting topic. Many results have been obtained on these kinds of problem, for example, [1-18]. If $w(r) \equiv p(r) \equiv p$ (a constant), ( P ) is the well-known $p$-Laplacian problem. Because of the nonhomogeneity of $p(x)$-Laplacian, $p(x)$-Laplacian problems are more complicated than those of $p$-Laplacian, many methods and results for $p$-Laplacian problems are invalid for $p(x)$-Laplacian problems. For example,
(1) if $\Omega \subset \mathbb{R}^{n}$ is an open bounded domain, then the Rayleigh quotient

is zero in general, and only under some special conditions $\lambda_{p(x)}>0$ (see [4]), but the fact that $\lambda_{p}>0$ is very important in the study of $p$-Laplacian problems. In [19], the author considers the existence and nonexistence of positive weak solution to the following quasilinear elliptic system:

the first eigenfunction is used to constructing the subsolution of problem (S) successfully. On the $p(x)$-Laplacian problems, maybe $p(x)$-Laplacian does not have the first eigenvalue and the first eigenfunction. Because of the nonhomogeneity of $p(x)$-Laplacian, the first eigenfunction cannot be used to construct the subsolution of $p(x)$-Laplacian problems, even if the first eigenfunction of $p(x)$-Laplacian exists. On the existence of solutions for $p(x)$ Laplacian equations Dirichlet problems via subsuper solution methods, we refer to [13, 14];
(2) if $w(r) \equiv p(r) \equiv p$ (a constant) and $-\Delta_{p} u>0$, then $u$ is concave, this property is used extensively in the study of one-dimensional $p$-Laplacian problems, but it is invalid for $-\Delta_{p(r)}$. It is another difference on $-\Delta_{p}$ and $-\Delta_{p(r)}:=-\left(\left|u^{\prime}\right|^{p(r)-2} u^{\prime}\right)^{\prime}$;
(3) on the existence of solutions of the typical $p(r)$-Laplacian problem:

\end{equation*}

because of the nonhomogeneity of $p(t)$-Laplacian, when we use critical point theory to deal with the existence of solutions, we usually need the corresponding functional is coercive or satisfy Palais-Smale conditions. If $1 \leq \max _{r \in[0,1]} q(r)<\min _{r \in[0,1]} p(r)$, then the corresponding functional is coercive, if $\max _{r \in[0,1]} p(r)<\min _{r \in[0,1]} q(r)$, then the corresponding functional
satisfies Palais-Smale conditions (see [3]). But if $\min _{r \in[0,1]} p(r) \leq q(r) \leq \max _{r \in[0,1]} p(r)$, one can see that the corresponding functional is neither coercive nor satisfying Palais-Smale conditions, the results on this case are rare.

There are many papers on the existence of solutions for $p$-Laplacian boundary value problems via subsuper solution method (see [20-24]). But results on the sub-super-solution method for $p(x)$-Laplacian equations and systems are rare. In this paper, when $p(r)$ is a general function, we establish several sub-super-solution theorems for the existence of solutions for weighted $p(r)$-Laplacian equation with Dirichlet, Robin, and Periodic boundary value conditions. Moreover, the case of $\min _{r \in[0,1]} p(r) \leq q(r) \leq \max _{r \in[0,1]} p(r)$ is discussed. Our results partially generalize the results of [13, 14, 20, 25].

Let $T_{1}<T_{2}$ and $I=\left[T_{1}, T_{2}\right]$, the function $f: I \times \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{R}$ is assumed to be Caratheodory, by this we mean the following:
(i) for almost every $t \in I$, the function $f(t, \cdot, \cdot)$ is continuous;
(ii) for each $(x, y) \in \mathbb{R} \times \mathbb{R}$, the function $f(\cdot, x, y)$ is measurable on $I$;
(iii) for each $\rho>0$, there is a $\alpha_{\rho} \in L^{1}(I, \mathbb{R})$ such that, for almost every $t \in I$ and every $(x, y) \in \mathbb{R} \times \mathbb{R}$ with $|x| \leq \rho,|y| \leq \rho$, one has

We set $C=C(I, \mathbb{R}), C^{1}=\left\{u \in C \mid u^{\prime}\right.$ is continuous in $\left(T_{1}, T_{2}\right), \lim _{r \rightarrow T_{1}^{+}} w(r)\left|u^{\prime}\right|^{p(r)-2} u^{\prime}(r)$ and $\lim _{r \rightarrow T_{2}^{-}} w(r)\left|u^{\prime}\right|^{p(r)-2} u^{\prime}(r)$ exist $\}$. Denote $\|u\|_{0}=\sup _{r \in\left(T_{1}, T_{2}\right)}|u(r)|$ and $\|u\|_{1}=\|u\|_{0}+$ $\left\|(w(r))^{1 /(p(r)-1)} u^{\prime}\right\|_{0}$. The spaces $C$ and $C^{1}$ will be equipped with the norm $\|\cdot\|_{0}$ and $\|\cdot\|_{1}$, respectively.

We say a function $u: I \rightarrow \mathbb{R}$ is a solution of $(\mathrm{P})$, if $u \in C^{1}$ and $w(r)\left|u^{\prime}\right|^{p(r)-2} u^{\prime}(r)$ is absolutely continuous and satisfies $(\mathrm{P})$ almost every on $I$.

Functions $\alpha, \beta \in C^{1}$ are called subsolution and supersolution of (P), if $\left|\alpha^{\prime}\right|^{p(r)-2} \alpha^{\prime}(r)$ and $\left|\beta^{\prime}\right|^{p(r)-2} \beta^{\prime}(r)$ are absolutely continuous and satisfy

Throughout this paper, we assume that $\alpha \leq \beta$ are subsolution and supersolution, respectively. Denote

We also assume that
$\left(\mathrm{H}_{1}\right)|f(t, x, y)| \leq A_{1}(t, x) K_{1}(t, x, y)+A_{2}(t, x) K_{2}(t, x, y)$, for all $(t, x, y) \in \Omega_{1}$, where $A_{i}(t, x)(i=1,2)$ are positive value and continuous on $\Omega_{0}, K_{i}(t, x, y)(i=1,2)$ are positive value and continuous on $\Omega_{1}$.
$\left(\mathrm{H}_{2}\right)$ There exist positive numbers $M_{1}$ and $M_{2}$ such that $K_{1}(t, x, y) \leq|y| \phi(|y|)$, $K_{2}(t, x, y) \leq M_{1} \phi(|y|)$, for $|y| \geq M_{2}$, where $\phi \in C([1,+\infty),[1,+\infty))$ is increasing and satisfies $\int_{1}^{+\infty}\left(1 / \phi\left(y^{1 /\left(p^{-}-1\right)}\right)\right) d y=\infty$, where $p^{-}=\min _{r \in I} p(r)$.

Our main results are as the following theorem.
Theorem 1.1. If $f$ is Caratheodory and satisfies $\left(H_{1}\right)$ and $\left(H_{2}\right), \alpha$ and $\beta$ satisfy $\alpha\left(T_{1}\right) \leq c \leq \beta\left(T_{1}\right)$, $\alpha\left(T_{2}\right) \leq d \leq \beta\left(T_{2}\right)$, then $(\mathrm{P})$ with (1.1) possesses a solution.

Theorem 1.2. If $f$ is Caratheodory and satisfies $\left(H_{1}\right)$ and $\left(H_{2}\right), \alpha$ and $\beta$ satisfy $\alpha\left(T_{2}\right) \leq d \leq \beta\left(T_{2}\right)$, and

g\left(\alpha\left(T_{1}\right),\left(w\left(T_{1}\right)\right)^{1 /\left(p\left(T_{1}\right)-1\right)} \alpha^{\prime}\left(T_{1}\right)\right) \geq 0 \geq g\left(\beta\left(T_{1}\right),\left(w\left(T_{1}\right)\right)^{1 /\left(p\left(T_{1}\right)-1\right)} \beta^{\prime}\left(T_{1}\right)\right) \tag{1.12}
\end{equation*}

then (P) with (1.2) possesses a solution.
Theorem 1.3. If $f$ is Caratheodory and satisfies $\left(H_{1}\right)$ and $\left(H_{2}\right), \alpha$ and $\beta$ satisfy

& h\left(\alpha\left(T_{2}\right),\left(w\left(T_{2}\right)\right)^{1 /\left(p\left(T_{2}\right)-1\right)} \alpha^{\prime}\left(T_{2}\right)\right) \leq 0 \leq h\left(\beta\left(T_{2}\right),\left(w\left(T_{2}\right)\right)^{1 /\left(p\left(T_{2}\right)-1\right)} \beta^{\prime}\left(T_{2}\right)\right)

then (P) with (1.3) possesses a solution.
Theorem 1.4. If $f$ is Caratheodory and satisfies $\left(H_{1}\right)$ and $\left(H_{2}\right), \alpha$ and $\beta$ satisfy

w\left(T_{1}\right)\left|\alpha^{\prime}\left(T_{1}\right)\right|^{p\left(T_{1}\right)-2} \alpha^{\prime}\left(T_{1}\right) \geq w\left(T_{2}\right)\left|\alpha^{\prime}\left(T_{2}\right)\right|^{p\left(T_{2}\right)-2} \alpha^{\prime}\left(T_{2}\right),  \tag{1.14}\\
w\left(T_{1}\right)\left|\beta^{\prime}\left(T_{1}\right)\right|^{p\left(T_{1}\right)-2} \beta^{\prime}\left(T_{1}\right) \leq w\left(T_{2}\right)\left|\beta^{\prime}\left(T_{2}\right)\right|^{p\left(T_{2}\right)-2} \beta^{\prime}\left(T_{2}\right),
\end{gather*}

then (P) with (1.4) possesses a solution.
As an application, we consider the existence of weak solutions for the following $p(x)$ Laplacian partial differential equation:

-\operatorname{div}\left(|\nabla u|^{p(x)-2} \nabla u\right)+f\left(x, u,|x|^{(n-1) /(p(x)-1)}|\nabla u|\right)=0, \quad \forall x \in \Omega \tag{1.15}
\end{equation*}

where $\Omega$ is a bounded symmetric domain in $\mathbb{R}^{n}, p \in C(\bar{\Omega} ; \mathbb{R})$ is radially symmetric. We will write $p(x)=p(|x|)=p(r)$, and $p(r)$ satisfies $1<p(r) \in C, f \in C(\bar{\Omega} \times \mathbb{R} \times \mathbb{R}, \mathbb{R})$ is radially symmetric with respect to $x$, namely, $f(x, u, v)=f(|x|, u, v)=f(r, u, v)$, and $f$ satisfies the Caratheodory condition.

## 2. Preliminary

Denote $\varphi(r, x)=|x|^{p(r)-2} x, \forall(r, x) \in I \times \mathbb{R}$. Obviously, $\varphi$ has the following properties.
Lemma 2.1. $\varphi$ is a continuous function and satisfies
(i) for any $r \in\left[T_{1}, T_{2}\right], \varphi(r, \cdot)$ is strictly increasing;
(ii) $\varphi(r, \cdot)$ is a homeomorphism from $\mathbb{R}$ to $\mathbb{R}$ for any fixed $r \in I$.

For any fixed $r \in I$, denote $\varphi^{-1}(r, \cdot)$ as

\varphi^{-1}(r, x)=|x|^{(2-p(r)) /(p(r)-1)} x, \quad \text { for } x \in \mathbb{R} \backslash\{0\}, \varphi^{-1}(r, 0)=0 \tag{2.1}
\end{equation*}

It is clear that $\varphi^{-1}(r, \cdot)$ is continuous and send bounded sets into bounded sets. Let us now consider the simple problem

with boundary value condition (1.1), where $f \in L^{1}$. If $u$ is a solution of (2.2) with (1.1), by integrating (2.2) from $T_{1}$ to $r$, we find that

Denote

F(f)(r)=\int_{T_{1}}^{r} f(t) d t, \quad a=w\left(T_{1}\right) \varphi\left(T_{1}, u^{\prime}\left(T_{1}\right)\right) \tag{2.4}
\end{equation*}

then

u(r)=u\left(T_{1}\right)+\int_{T_{1}}^{r} \varphi^{-1}\left[r,(w(r))^{-1}(a+F(f)(r))\right] d r \tag{2.5}

The boundary conditions imply that

For fixed $h \in C$, we denote

We have the following lemma.
Lemma 2.2. The function $\Lambda_{h}$ has the following properties. (i) For any fixed $h \in C$, the equation

has a unique solution $\tilde{a}(h) \in \mathbb{R}$.
(ii) The function $\tilde{a}: C \rightarrow \mathbb{R}$, defined in (i), is continuous and sends bounded sets to bounded sets.

Proof. (i) Obviously, for any fixed $h \in C, \Lambda_{h}(\cdot)$ is continuous and strictly increasing, then, if (2.8) has a solution, it is unique.

Since $(w(r))^{-1 /(p(r)-1)} \in L^{1}\left(T_{1}, T_{2}\right)$ and $h \in C$, it is easy to see that

It means the existence of solutions of $\Lambda_{h}(a)=0$.
In this way, we define a function $\tilde{a}(h): C\left[T_{1}, T_{2}\right] \rightarrow \mathbb{R}$, which satisfies

(ii) We claim that

If it is false. Without loss of generality, we may assume that there are some $h \in C$ such that

& \int_{T_{1}}^{T_{2}} \varphi^{-1}\left[r,(w(r))^{-1}(\tilde{a}(h)+h(r))\right] d r+d-c \\
& >\left\{\frac{|c-d|}{\int_{T_{1}}^{T_{2}} \varphi^{-1}\left[r,(w(r))^{-1}\right] d r}+1\right\} \int_{T_{1}}^{T_{2}} \varphi^{-1}\left[r,(w(r))^{-1}\right] d r+d-c  \tag{2.13}\\
& =|c-d|+\int_{T_{1}}^{T_{2}} \varphi^{-1}\left[r,(w(r))^{-1}\right] d r+d-c \\

It is a contradiction. Thus, (2.11) is valid. It mens that $\tilde{a}$ sends bounded sets to bounded sets.

Finally, to show the continuity of $\tilde{a}$, let $\left\{u_{n}\right\}$ be a convergent sequence in $C$ and $u_{n} \rightarrow$ $u$, as $n \rightarrow+\infty$. Obviously, $\left\{\tilde{a}\left(u_{n}\right)\right\}$ is a bounded sequence, then it contains a convergent subsequence $\left\{\tilde{a}\left(u_{n_{j}}\right)\right\}$. ## 3. Proofs of main results

In this section, we will deal with the proofs of main results.

By virtue of Schauder fixed point theorem, $\Phi_{\tilde{f}}(u)$ has at least one fixed point $u$ in $C_{c, d}^{1}$. Then, $u$ is a solution of SBVP with (1.1). This completes the proof.

Repeated the step, we get two sequences $\left\{u_{n}\right\}$ and $\left\{v_{n}\right\}$, all are solutions of $(\mathrm{P})$, and satisfy

According to Lemma 2.5, $\left\{u_{n}(t)\right\}$ and $\left\{v_{n}(t)\right\}$ both are bounded in $C^{1}$, then $\left\{\left(w\left(T_{1}\right)\right)^{1 /\left(p\left(T_{1}\right)-1\right)} u_{n}^{\prime}\left(T_{1}\right)\right\}$ is a bounded set and has a convergent subsequence. Note that $\left\{u_{n}(t)\right\}$ are solutions of $(\mathrm{P})$ and satisfy

From [2], we can see that $\left\{u_{n}(t)\right\}$ and $\left\{v_{n}(t)\right\}$ have uniform $C^{1, \alpha}$ regularity. We may assume that $u_{n_{i}}(t) \rightarrow u(t)$ in $C^{1}$ and $v_{n_{i}}(t) \rightarrow v(t)$ in $C^{1}$.

It is easy to see that $u(t) \leq v(t)$ both are solutions of $(\mathrm{P})$. From the definition of $\left\{u_{n}(t)\right\}$ and $\left\{v_{n}(t)\right\}$, we can see that

If $h\left(x\left(T_{2}\right),\left(w\left(T_{2}\right)\right)^{1 /\left(p\left(T_{2}\right)-1\right)} x^{\prime}\left(T_{2}\right)\right)>0$, then denote $v_{2}(t)=x(t)$ and $u_{2}(t)=u_{1}(t)$,
if $h\left(x\left(T_{2}\right),\left(w\left(T_{2}\right)\right)^{1 /\left(p\left(T_{2}\right)-1\right)} x^{\prime}\left(T_{2}\right)\right)<0$, then denote $v_{2}(t)=v_{1}(t)$ and $u_{2}(t)=x(t)$. It is easy to see that $u_{2}(t)$ and $v_{2}(t)$ both are solutions of (P) and satisfy

We may assume that $u_{n_{i}}(t) \rightarrow u(t)$ in $C^{1}$, and similar $v_{n_{j}}(t) \rightarrow v(t)$ in $C^{1}$. It is easy to see that $u(t) \leq v(t)$ both are solutions of (P) with (1.3). This completes the proof.

Proof of Theorem 1.4. According to Theorem 1.1, (P) possesses solution $u_{1}$ which satisfies

According to Theorem 1.1, ( P ) possesses solutions $v_{1}$ which satisfies

According to Theorem 1.1, (P) possesses solutions $x$ and satisfies

From (3.41), (3.42), and (3.43), we can conclude that ( P ) with (1.4) possesses a solution. This completes the proof.

On the case of $\min _{r \in[-R, R]} p(r) \leq q(r) \leq \max _{r \in[-R, R]} p(r)$, we consider

We have the following corollary.
Corollary 3.1. If $p \in C(\mathbb{R},(1,+\infty))$ is even, $R$ satisfies

& \geq\left(\int_{0}^{R}|s|^{1 /\left(p^{+}-1\right)} d s\right)^{1-p^{-}} \geq 1+C+\max _{r \in[-R, R]} e(r) \geq C|\beta|^{q(r)-2} \beta+e(r)
\end{align*}
$$

where $\xi \in[-R, R]$. Then, $\beta$ is a supersolution of (I). From Theorem 1.1, one can see that (I) possesses at least a nontrivial solution.

## 4. Applications in PDE

Let $\Omega \subset \mathbb{R}^{n}$ be an open bounded domain. In this section, we always denote

$$
\begin{equation*}
p^{+}=\max _{x \in \bar{\Omega}} p(x), \quad p^{-}=\min _{x \in \bar{\Omega}} p(x) . \tag{4.1}
\end{equation*}
$$

Let us now consider (1.15) with one of the following boundary value conditions:

\nabla u=0, \quad \forall x \in \partial \Omega \tag{4.3}
\end{gather*}
$$

If $u$ is a radial solution of (1.15), then it can be transformed into

\end{equation*}

and the boundary value condition will be transformed into (1.1), (1.2), or (1.3), respectively.
Theorem 4.1. If (4.4) has subsolution and supersolution $\alpha$ and $\beta$, respectively, satisfying $\alpha(t) \leq \beta(t)$ for any $t \in\left[T_{1}, T_{2}\right]$, and $f$ is continuous and satisfies $\left(H_{1}\right)-\left(H_{2}\right)$, in each of the following cases:
(i) $0<T_{1}<T_{2}, \Omega=\left\{x \in \mathbb{R}^{n}\left|T_{1}<|x|<T_{2}\right\}, \alpha\left(T_{1}\right) \leq 0 \leq \beta\left(T_{1}\right)\right.$, and $\alpha\left(T_{2}\right) \leq 0 \leq \beta\left(T_{2}\right)$;
(ii) $0=T_{1}<T_{2}, \Omega=\left\{x \in \mathbb{R}^{n}\left|T_{1}<|x|<T_{2}\right\}=B\left(0 ; T_{2}\right) \backslash\{0\}\right.$, and $p^{-}>n ; \alpha\left(T_{1}\right) \leq 0 \leq$ $\beta\left(T_{1}\right), \alpha\left(T_{2}\right) \leq 0 \leq \beta\left(T_{2}\right) ;$
(iii) $0=T_{1}<T_{2}, \Omega=\left\{x \in \mathbb{R}^{n}| | x \mid<T_{2}\right\}=B\left(0 ; T_{2}\right)$, and $p^{-}>n ;\left(w\left(T_{1}\right)\right)^{1 /\left(p\left(T_{1}\right)-1\right)} \alpha^{\prime}\left(T_{1}\right) \geq$ $0 \geq\left(w\left(T_{1}\right)\right)^{1 /\left(p\left(T_{1}\right)-1\right)} \beta^{\prime}\left(T_{1}\right), \alpha\left(T_{2}\right) \leq 0 \leq \beta\left(T_{2}\right) ;$
then (1.15) with (4.2) has at least one weak radially symmetric solution $u$.
Proof. Notice that $\left(r^{n-1}\right)^{-1 /(p(r)-1)} \in L^{1}\left(0, T_{2}\right)$ and satisfies $0<r^{n-1}, \forall r \in\left(0, T_{2}\right)$. We can conclude the existence of solutions for (4.4) with (1.1), (1.2), or (1.3), from Theorems 1.1, 1.2, and 1.3. If $\lim _{r \rightarrow 0} r^{n-1}\left|u^{\prime}\right|^{p(r)-2} u^{\prime}(r)=0$, notice that

$$
\begin{align*}
\left|\left|u^{\prime}\right|^{p(r)-2} u^{\prime}(r)\right| & \leq r^{1-n} \int_{0}^{r} t^{n-1}\left|f\left(t, u,|t|^{(n-1) /(p(t)-1)}\left|u^{\prime}\right|\right)\right| d t  \tag{4.5}\\
& \leq \int_{0}^{r}\left|f\left(t, u,|t|^{(n-1) /(p(t)-1)}\left|u^{\prime}\right|\right)\right| d t \longrightarrow 0 \quad(\text { as } r \longrightarrow 0)
\end{align*}
$$

then we have $u^{\prime}(0)=0$. This completes the proof.
Similarly, we have the following theorem.
Theorem 4.2. If (4.4) has subsolution and supersolution $\alpha$ and $\beta$, respectively, satisfying $\alpha(t) \leq \beta(t)$ for any $t \in\left[T_{1}, T_{2}\right]$, and

$$
\begin{align*}
& \left(w\left(T_{1}\right)\right)^{1 /\left(p\left(T_{1}\right)-1\right)} \alpha^{\prime}\left(T_{1}\right) \geq 0 \geq\left(w\left(T_{1}\right)\right)^{1 /\left(p\left(T_{1}\right)-1\right)} \beta^{\prime}\left(T_{1}\right)  \tag{4.6}\\
& \left(w\left(T_{2}\right)\right)^{1 /\left(p\left(T_{2}\right)-1\right)} \alpha^{\prime}\left(T_{2}\right) \leq 0 \leq\left(w\left(T_{2}\right)\right)^{1 /\left(p\left(T_{2}\right)-1\right)} \beta^{\prime}\left(T_{2}\right)
\end{align*}
$$

and $f$ is continuous and satisfies $\left(H_{1}\right)-\left(H_{2}\right)$, in each of the following cases:
(i) $0<T_{1}<T_{2} ; \Omega=\left\{x \in \mathbb{R}^{n}\left|T_{1}<|x|<T_{2}\right\}\right.$;
(ii) $0=T_{1}<T_{2} ; \Omega=\left\{x \in \mathbb{R}^{n}\left|T_{1}<|x|<T_{2}\right\}=B\left(0 ; T_{2}\right) \backslash\{0\}\right.$ or $\Omega=B\left(0 ; T_{2}\right) ; p \in C^{1}(\bar{\Omega} ; \mathbb{R})$ and $p^{-}>n$;
then (1.15) with (4.3) has at least one weak radially symmetric solution $u$.
On the case of $p^{-} \leq q(x) \leq p^{+}$, we consider

$$
\begin{gather*}
-\operatorname{div}\left(|\nabla u|^{p(x)-2} \nabla u\right)=C|u-1|^{q(x)-2} u+e(x), \quad x \in \Omega, \\
u(x)=0, \quad x \in \partial \Omega, \tag{II}
\end{gather*}
$$

where $\Omega=\left\{x \in \mathbb{R}^{n}|0<|x|<R\}, q(x), e(x) \in C\left(\bar{\Omega}, \mathbb{R}^{+}\right), 2 \leq n<p^{-} \leq q(x) \leq p^{+}, C\right.$ is a positive constant.

We have the following corollary.
Corollary 4.3. If $p \in C\left(\mathbb{R}^{n},(1,+\infty)\right)$ is radial, and $R$ satisfies

$$
\begin{equation*}
R \leq \min \left\{1,\left[\left(1-\frac{1}{2\left(p^{-}-1\right)}\right)^{p^{+}-1} \frac{(n-3 / 2)}{1+C+\max _{x \in \bar{\Omega}} e(x)}\right]^{1 /\left(p^{-}-3 / 2\right)}\right\} \tag{4.7}
\end{equation*}
$$

then (II) possesses at least a nontrivial solution.
Proof. It is easy to see that $\alpha \equiv 0$ is a subsolution of (II). Denote

$$
\begin{equation*}
\beta(r)=1-\int_{0}^{r}\left|\mu s^{-1 / 2}\right|^{1 /(p(s)-1)} d s \tag{4.8}
\end{equation*}
$$

where $\mu$ is a positive constant satisfying $\beta(R)=0$. It is easy to see that $0 \leq \beta(r) \leq 1, \forall r \in[0, R]$, and

$$
\begin{align*}
-\left(r^{n-1}\left|\beta^{\prime}\right|^{p(r)-2} \beta^{\prime}\right)^{\prime} & =\mu\left(n-\frac{3}{2}\right) r^{n-5 / 2}=\left(\int_{0}^{R}|s|^{-1 / 2(p(s)-1)} d s\right)^{1-p(\xi)}\left(n-\frac{3}{2}\right) r^{n-5 / 2} \\
& \geq\left(\int_{0}^{R}|s|^{-1 / 2\left(p^{-}-1\right)} d s\right)^{1-p(\xi)}\left(n-\frac{3}{2}\right) r^{n-1}  \tag{4.9}\\
& \geq\left(R^{-1 / 2\left(p^{-}-1\right)+1}\right)^{1-p^{-}}\left(1-\frac{1}{2\left(p^{-}-1\right)}\right)^{p^{+}-1}\left(n-\frac{3}{2}\right) r^{n-1} \\
& \geq r^{n-1}\left[1+C+\max _{x \in \bar{\Omega}} e(x)\right] \geq r^{n-1}\left[C|\beta-1|^{q(x)-2} \beta+e(x)\right]
\end{align*}
$$

where $\xi \in \bar{\Omega}$. Then, $\beta$ is a supersolution of (II). From Theorem 4.1, one can see that (II) possesses at least a nontrivial solution.
